

## Update to physician feedback report on AppCentral

### Trace document follows progress on user-reported issues

BC MQI has published an update on the physician issues and recommendations regarding AppCentral—the program that health authority medical staffs now use to complete their appointment and renewal applications online.

Back in 2016, following the first year of online re/appointments, BC MQI gathered physician feedback on their experience using the new system. Physician input was drawn both from health authority credentialing offices and directly from physicians—via feedback and support channels, surveys, and a focus group. As a result, MQI was able to identify and prioritize the improvements needed to refine the system over the coming years. The plan and vision for these improvements were shared in an [August 2016 report](#), which remains available at bcmqi.ca.

The new trace document is the first follow up to physician feedback and recommendations on AppCentral. It details the steps taken to date to ameliorate user issues. For example, measures taken have aimed to improve page-load times, to simplify navigation of the privileging dictionaries, and to streamline the attachment uploads.

BC physicians continue to inform the broader vision for our provincial system for credentialing and privileging. In the last year, BC MQI has coordinated direct conversations between BC physicians and the software vendor, to discuss a “physician portal” for organizing and accessing physician data. In this way, BC physicians are helping to shape the next iteration of AppCentral, which is still in an early development stage.

## Dictionary refresh

### Reviews in progress

This month will see new review panels launch for the otolaryngology, neurology and pediatric dictionaries. Panel work continues on gastroenterology, orthopedic surgery, urology, anesthesiology, critical care, and diagnostic imaging, as well as a sub-panel for procedural pain management.

Sub-panel work on a new dictionary for Acute Stroke Endovascular Treatment has been discontinued. BC MQI has referred the matter to Stroke Services BC, who may look to determine the service delivery model and locations for Acute Stroke EVT; elements that should be in place before a practice dictionary is developed.
